**Advisory Committee on the Microbiological Safety of Blood and Tissue for Transplantation (MSBT)**

**Introduction**

1. Ministers are asked to approve the replacement of the existing Advisory Committee on the Virological Safety of Blood (ACVSB) by a new expert committee, the MSBT, to advise on a much wider range of microbiological safety issues that affect blood, tissues and organs for transplantation. The new committee would provide a co-ordinated source of advice on tissues and organs for the first time.

**Background**

2. In 1989 UK Health Ministers established the ACVSB to advise on safety issues affecting the blood supply in view of the growing awareness by the public of safety issues in health. No similar body exists in respect of tissues and organs for transplantation although many of the same risks of transmitting diseases exist as with blood. Advice in respect of safety issues on transplantation is sought from a variety of sources and where appropriate advice from the ACVSB in relation to blood has also been promulgated to transplants. These ad hoc arrangements can form a useful contribution to Departmental thinking but are not a proper basis for formulating Departmental policy.
3. Professional and administrative officials are agreed on the need for a new Committee and recommend that the ACVSB should be replaced by the MSBT. This new Committee would advise on the full range of microbiological safety issues which affect both blood and tissues for transplantation, and thereby avoid the duplication that would arise from having separate bodies examining many of the same issues in respect of blood supply and tissue transplants. The suggested terms of reference are set out in Annex A.

4. Furthermore, the ACVSB have increasingly found that they have had to consider non-virological aspects of blood safety. This is beyond its present remit but in the absence of another body responsible for giving advice on such matters, the ACVSB has been asked to do so.

#### Composition of the new Committee

5. It is suggested that the new body should be chaired by the DCMO, Dr Metters who currently chairs the ACVSB. Membership should be drawn from the existing ACVSB and to reflect the widened remit of the MSBT two microbiologists would be substituted for two of the four current virologists, and two transplant surgeons would be added to the membership.
6. We believe this would provide the MSBT with the proper balance of expertise to carry out its functions while ensuring that numbers do not make the Committee unwieldy. The suggested membership list is at Annex B.

#### Other Health Departments

7. The MSBT would advise all UK Health Ministers and the Territorial Departments would each have their own observer on the new Committee. A letter for Minister to send to his Territorial colleagues is at Annex C.

#### Decisions sought

8. Minister is asked to agree to:-
  - i) the winding up of the ACVSB; and
  - ii) the establishment of the MSBT with the terms of reference at Annex A. If so, officials will write inviting the proposed members to serve.
